Leadership, Human Resources and Organizational Change

This track prepares students for managerial and consulting roles, primarily, though not exclusively, in the fields of human resource management and organizational change.

The skills acquired enable graduates to pursue careers such as HR Business Partner, Talent Acquisition Specialist, Change Management Consultant, Project Manager, and Organizational Development Manager, in private companies, public institutions, consulting firms, and international organizations.

Business Management

This track prepares students for professional careers in the strategic and financial management of companies.

The skills acquired enable graduates to pursue careers such as Business Analyst, Controller, Marketing Specialist, Project Manager, and Business Strategy Consultant.

Career opportunities can be found in multinational companies, consulting firms, financial institutions, public institutions, and non-profit organizations.

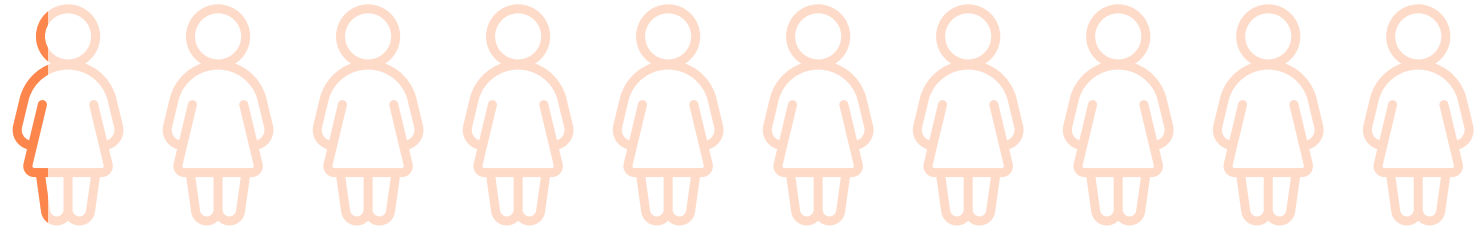

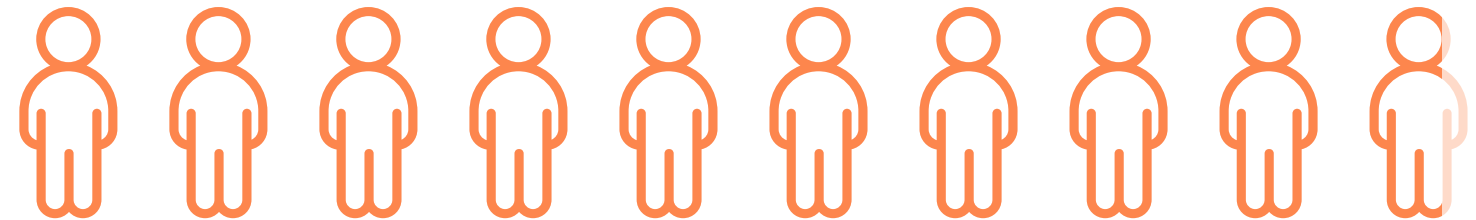
Sector of employment

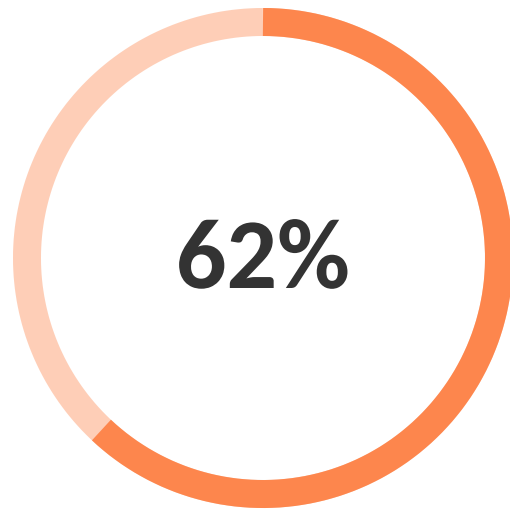
Public Sector

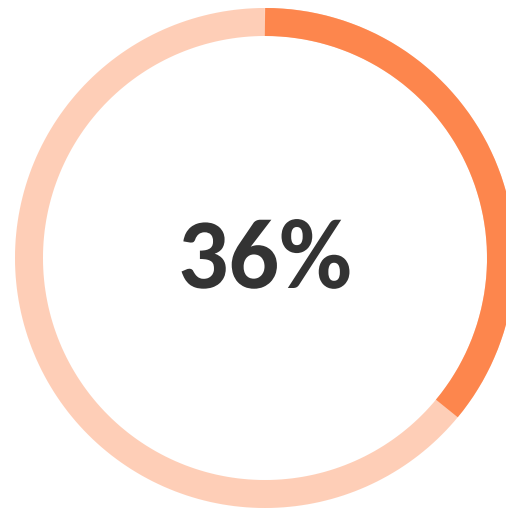


Private Sector

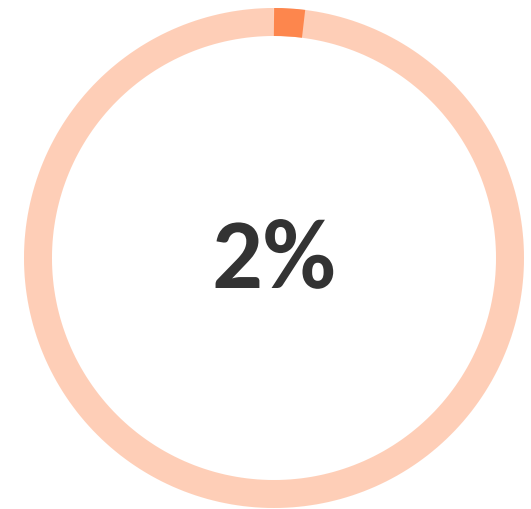
Perceived adequacy of University professional training



Highly adequate

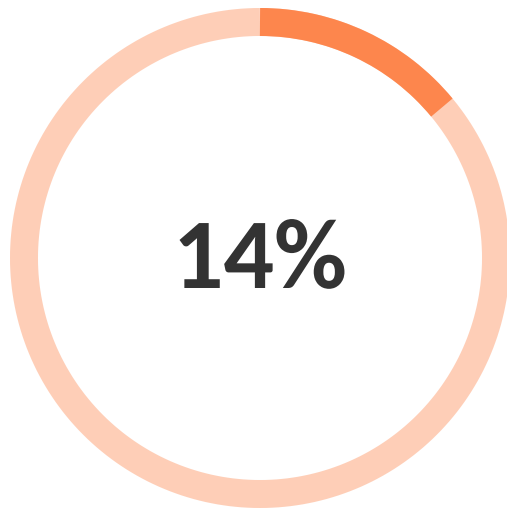

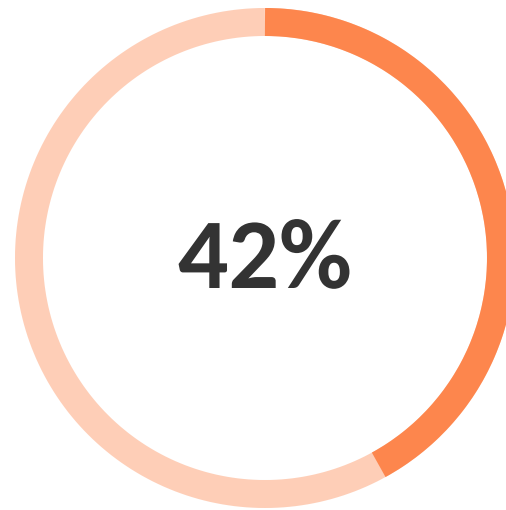

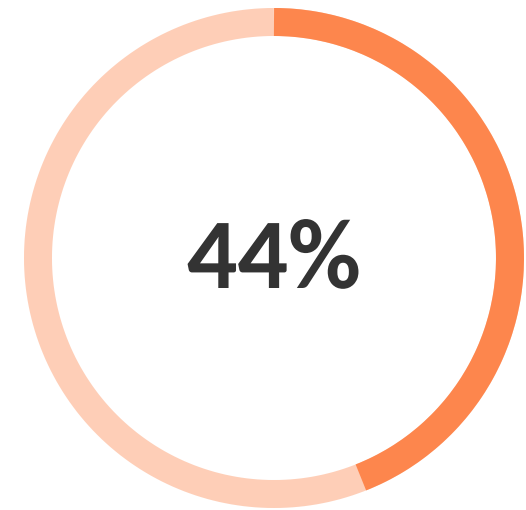

2 Degree Paths

The program offers two degree paths: Leadership, risorse umane e cambiamento organizzativo (**Leadership, Human Resources, and Organizational Change**) and Gestione Aziendale (**Business Management**)
